# Tender No. PUR/NIPERHYD/NC/30/19 – HPLC SYSTEM WITH PDA DETECTOR

Subsequent to the pre bid conference held in the Institute in connection with procurement of HPLC System with PDA Detector against our tender No.PUR/NIPERHYD/NC/30/19, the Institute would like to add following information to the existing tender document.

- 1. The Institute would like to have additional 2 years comprehensive warranty coverage as an optional item. Suppliers are expected to quote separately for 2<sup>nd</sup> year and 3<sup>rd</sup> year cost implications towards additional warranty obligations. In case Institute desires to have additional warranty beyond 1 year the payment towards 2<sup>nd</sup> and 3rd year will be paid only after successful completion of warranty obligations each additional year separately.
- 2. As the Institute do not have any clearing agent, the Institute expects the suppliers to handle clearance of items from customs wherever applicable. However the Institute will provide required documents like duty exemption certificate, IEC Code and any other declaration to be given by Institute. The prices should be quoted in FOR upto NIPER Hyderabad Stores.
- 3. The list of following items quoted separately which may be added to the cost of main unit for the purpose of comparison. Depending on the budget availability Institute may select the required items from the following and only those selected items will be added for comparison purpose.

Following specifications will be added to the specifications of HPLC.

- 1. Auto sampler- Sample cooler /thermostat should have capability to cool to heat (around 5°C up to 40°C).
- 2. Comprehensive warranty: 3 years from date of installation (including computer and software's supplied)
