TERMS & CONDITIONS

- 1. Quotations received after due date & time shall be summarily ignored.
- 2. Each quotation sent by post is to be enclosed in double cover. The cover should be SEALED WITH AND SUPERSCRIBED with tender number and due date. Quotations should be addressed to "Director NIPER HYD" and delivered personally should be put in the tender box kept in the office of Stores & Purchase, NIPER Hyderabad. All the bids are to be submitted in two bid system i.e. technical and commercial bids separately in different sealed covers. The EMD amount of Rs.54,000/- in the form of DD or bankers Cheque in favour of "NIPER-H Resources" should be kept in the technical bid cover to avoid its disgualification.
- 3. The quotation sent by Fax/e-mail, can be accepted at your risk provided the quotation reaches the Purchase Dept. within the due date & time. If the Tender Opening Day falls on a Public Holiday, the tender will be opened on next working day. Quotations should be submitted only on working days.
- 4. The bids would be opened in the presence of the bidders who wish to attend the Bid-opening. However the representative should bring with them a letter of

authority from the corresponding bidders, without which, they are not permitted to attend the Bid-opening.

- 5. The acceptance of the quotation will rest with the competent authority of NIPER, Hyderabad who does not bind himself to accept the lowest quotation and reserves the right to himself to reject, or partially accept any or all the quotations received without assigning any reasons.
- 6. Your offer shall be valid for ninety days from the date of opening of the quotations. No revision in price will be allowed after opening the quotation.
- 7. Unsolicited/conditional/Unsigned tenders shall not be considered.
- 8. Wherever the quoted price is more than Rs.10.00Lakhs unconditional Performance guarantee for 10% of the purchase order value valid till 60 days beyond end of warranty period need to be given.
- 9. Send your offer indicating the basic cost, taxes, packing, forwarding, freight, transportation, insurance, installation & commissioning charges etc., separately to ascertain the F.O.R NIPER HYD destination prices. The offers which are not complying with this condition are liable for rejection. - 1. Working temperature range should be between -20 °C or less to +40 or more.
- 2. Tank capacity between 7 to 15.
- 3. Pump capacity flow rate (I/min): between 16.5 to 25 I/min
- 4. Pump capacity flow pressure: 1.0 bar or less than 1.0 bar
- 5. Temperature stability on board (°C): between -0.5 to +0.5 °C.
- 6. Accuracy display resolution: need to be 0 to 0.1 °C.
- Cooling capacity: @20 °C (b/w 400 to 950 W), @0 °C (b/w 350 to 550 W), @-20 °C (b/w 100 to 200 W).
