

IMPORTANT NOTICE FOR PHASE-III WEB COUNSELLING

All the candidates who have participated in 1st & 2nd phase of counselling of NIPER JEE 2021 and have downloaded the allotment letter and also the candidates participating in 3rd phase of counselling should note the following:

The allotment process is software based system generated, hence there is no manual interference. The allotment is exactly according to online form filled by the candidates at the time of applying for NIPER JEE 2021. The software is designed in such a way that while allotting a seat to the candidate it takes care of specific category. After seat allotment those who download the allotment letter will be required to submit the undertaking, category certificate, qualifying degree certificate, medical certificate, migration, proof of age and other relevant certificates (if any) **to respective NIPER only**, when they will report for their admission and commencement of the classes. Validity and acceptance of a particular certificate will be decided by the respective NIPER. However, all the relevant certificates must be submitted before the commencement of 1st semester of their examination, till then, the admission will be provisional and only then they will be allowed to appear in the semester examination.

3rd Phase of Online Web Counselling will start from 12.08.2021 as per details given below:

- 1. Registration & Web options selection – 2 days i.e. from 12.08.2021 to 13.08.2021 till 6:00 PM**
- 2. Verification of selected web options – 1 working day i.e. 16.08.2021**
- 3. Admission Fee Payment & Downloading of Provisional Seat Allotment letter – 1 day i.e. on 17.08.2021 till 8:00 PM**

NIPER JEE 2021 Phase III Web Options Procedure & Conditions:

(A) Phase III Web Options Procedure & Conditions:

1. Fresh candidate participating in Phase-III web counselling will be required to pay the registration fee.
2. Those who have already paid the registration fee in Phase-I or Phase-II, they need not to pay the registration fee again. The candidates will be allowed to avail the Sliding option only once from Phase I to Phase-III.
3. The candidate who has opted for sliding option YES in Phase-II and also has downloaded the admission letter in Phase-II shall be allowed to participate in Phase-III.
4. The candidate who has opted for sliding in Phase-II and has not downloaded the admission letter in Phase - II shall be allowed to participate in Phase-III as a fresh candidate.

(B) Allotment process Procedure & Conditions:

1. The candidates who have not paid the admission fee in Phase -II, their seats will be cancelled.
2. In the sliding process, the candidates who have opted for sliding in Phase-II will be allotted new seats if available as per their choice in Phase-III otherwise they can retain their original allotment in phase - II.
3. The fresh candidates in Phase - III will be allotted the seats as per their web option preferences and as per available vacancy.
4. Revised allotment letter will be given for the sliding candidates without any admission fee payment. In case of a fresh candidate, the candidate has to pay the admission fee to download the admission letter if allotted.
