The Institute offers doctoral programmes in Chemical Sciences, Biological Sciences, Pharmaceutical Sciences and Pharmaceutical Management disciplines.

The Institute invites applications for admission into Ph.D programme from the suitable industry sponsored candidates for the academic year 2020-21.

i) Qualifying degree with a minimum of 60% marks in aggregate or Cumulative Grade Point Average of 6.75 on a 10-point scale.

- ii) Minimum relevant working experience of two years in his or her sponsoring employer's organization afterthe qualifying degree. A salary statement for these two years shall be required.
- iii) Sponsorship certificate from sponsoring organization in the form of an undertaking that the sponsored employee shall be treated on duty and paid his or her usual salary and allowances for the period of studies/research at this Institute. Such employees shall be fully relieved by the employer for studies/research.
- iv) Reputed Private Pharmaceutical Enterprises shall mean "Industry/Government Sponsored, a Trust, a Private Limited Company, a partnership/LLP company. A self-employed person/Small Scale entrepreneur having Drug Manufacturing License and 3-year experience of running Pharma Unit can sponsor himself and Income Tax Returns for 3 years should be sought for considering eligibility. Industry/Government Sponsored sponsoring candidates should have an annual turnover of Rs. 100 Crores (for Private Limited Company); 10 Crores (for Partnership/Limited Liability Partnership Company); 2 Crores (for self-employed) respectively. Besides above, candidate should be one whose Provident Fund is deducted by the employer.
- v) Where an employer wishes to withdraw the sponsorship, such employer shall be required to give cogent reasons for the withdrawal. The student then will be given an opportunity to put forth his or her side of the issue. Where the Dean and Director are satisfied that the student has violated any terms and conditions of the agreement with the employer, such person shall cease to be student of the Institute. Where student has not violated any terms and conditions of the agreement with his employer, he or she shall be allowed to complete his or her studies. No fees shall be refunded in any situation.
- vi) Selected Candidates shall be admitted to the programme, after he/she deposits fee for first semester in the shape of Demand Draft at the time of his/her admission.

2. How to apply:

Eligible candidates may fill the application form given in Annexure-1 (Page no. 4). The scanned copies of duly filled application form and other documents shall be sent to <u>dean@niperhyd.ac.in</u> on or before 15th September, 2020 by 5:00 pm.

3. Admission Procedure:

The shortlisted candidates will be called for an interview. The candidates have to report to the institute for Interview on scheduled date and time. Candidates will be allowed to participate in the Interview, only if they are carrying duly filled in application form supported by bio-data and one set of attested photocopies of certificates of educational qualification(s), age, experience, caste (in case of SC/ST/OBC candidates), latest passport size photograph, salary statement, sponsorship certificate from sponsoring organization. The candidates are required to bring all the original certificates for verification.

4. Documents to be submitted

The candidates will be required to submit the following documents in original and a set of photocopies of these certificates at the time of interview, failing which, the candidature shall be summarily rejected:

- 4.1. Application Form Printout (02 Copies) as given in **Annexure-1**
- 4.2. Matriculation Certificate as a proof of age and correct name.
- 4.3. Mark sheets of all the semesters' years of qualifying degree.
- 4.4. Original Migration Certificate (Last University/ Institute Attended)
- 4.5. Caste certificate, if applicable.
- 4.6. Certificate of disability, if applicable.

4.7. Sponsorship certificate from the employer in case of Government/Industry sponsored candidates as per form attached at **Annexure-2**.

5. Fees and payments

The selected candidates (For the academic year 2020-21) have to pay ₹ 1,66,760/- at the time of admission and from second semester onwards ₹ 1,06,400/- for each semester.
