

3rd Phase of Web Counseling for Masters & PhD Programme

Candidates who have participated in 1st & 2nd phase of counseling of NIPER JEE 2022 and candidates who are participating for the first time in 3rd phase of counselling should read and understand the “Instructions for Online Counselling for Masters & Ph.D. Programmes” which are available in NIPER Hyderabad Website and NIPER JEE 2022 Portal, before participating in 3rd Phase of Web-Counselling.

3rd Phase of Online Web Counselling will start from 05.08.2022 as per details given below:

1. Registration & Web options selection (By Candidate) – 2 days i.e. from 05.08.2022 to 06.08.2022 till 6:00 PM
2. Verification of selected web options (By NIPER) – 1 day i.e. from 09.08.2022
3. Admission Fee Payment & Downloading of Provisional Seat Allotment letter (By Candidate) – 2 days i.e. from 10.08.2022 to 11.08.2022 till 5:00 PM

Important Note:

1. If the web-counselling registration fee amount has not been paid in Phase-I/Phase-II, then candidates will be required to pay the registration fee in Phase-III.
2. Similarly if the registration fee has been already paid in Phase-I/Phase-II, then there is no need to pay the registration fee and candidates can directly submit their web options in Phase - III.
3. The candidate who has opted for sliding option YES in Phase-II and also has downloaded the admission letter in Phase-II shall be given provision for Phase-III with no further sliding option.
4. The candidate who has opted for sliding in Phase-II and has not paid the admission fee in Phase - II shall be given provision for Phase-III with sliding option.
5. **The candidates who have opted sliding ‘YES’ & downloaded the allotment letter in Phase-II and willing to participate in Phase-III are advised to read and understand carefully the “Sliding/Upgradation” procedure which is already mentioned in the “Counselling Instructions – Masters & PhD” available on the website**
6. **The sliding candidates are advised not to choose the Course and/or NIPER which was already confirmed by them in Phase-II and are advised to choose only those courses and/or NIPERs which are felt better by the candidates and willing to join (if allotted) than the already confirmed Course and/or NIPER**
7. The candidates who have not paid the admission fee in Phase -II, their allotted seat will be cancelled automatically.
8. Revised allotment letter will be given for the sliding candidates without any admission fee payment, if a new seat is allotted after sliding. In case of a fresh candidate, the candidate has to pay the admission fee amount to download the admission letter, if seat allotted.
9. The date of reporting to the institute will be intimated/notified in due course of time by respective NIPER.

In case of any discrepancy, the decision of NIPER JEE 2022 committee shall be final and binding on the candidates
