

**NIPER JEE - 2022**  
**INSTRUCTIONS for ONLINE COUNSELLING**  
**for Integrated PG-PhD PROGRAMME**

→ **GENERAL INSTRUCTIONS:**

- Candidates must ensure that all the eligibility conditions, as specified in the NIPER JEE 2022 Information Brochure available on NIPER Hyderabad website ([www.niperhyd.ac.in](http://www.niperhyd.ac.in)) are fulfilled.
- All the candidates appeared in NIPER JEE 2022 and participating in Web Counselling will be required to submit an Affidavit on Rs.10 (or above) Non-Judicial Stamp Paper that they will submit the requisite document(s) as specified in Information Brochure at the time of reporting to the respective NIPER for admission. Those who will fail in doing so, will not be allowed to participate in the web counselling. The format of **undertaking/affidavit (Annexure 1)** is available for download in NIPER Hyderabad Website and NIPER JEE 2022 portal
- **There will be only one round of counselling for integrated PG-PhD programme.**
- **Candidates who have applied for both Masters & integrated PG-PhD programme and confirms integrated PG-PhD seat after paying the prescribed admission fee, he/she will not be allowed to participate in Masters programme web counselling.**
- **However, if a candidate wishes to participate in Masters Programme counselling, the admission fee paid in integrated PG-PhD programme shall neither be refunded nor adjusted towards the PG seat, if allotted. The candidate will be required to pay the admission fee for Masters programme separately and in this case, the already confirmed seat in integrated PG-PhD programme stands cancelled and the candidate will not have any right to claim for the seat at a later stage.**

→ **ONLINE WEB COUNSELLING**

- Candidates should visit the website [www.niperhyd.ac.in](http://www.niperhyd.ac.in) / portal for participating in online web counselling.

- The eligible candidates shall register by paying one-time NON-REFUNDABLE advance fee (Rs 500/- for Gen & OBC, Rs 300 for SC/ST) through Online payment gateway. This fee will be adjusted with your admission fees in case your admission is confirmed. However, this advance fee will not be refunded in any case even if you do not take admission to allotted seat or no seat is allotted to you in the counselling.
- There will be OTP authentication through email and/or SMS on the registered email ID/Mobile Number for web counselling registration.
- The candidate has to set preferences to only those NIPERs that are offering the course chosen by the candidate at the time of submitting online application.
- Candidates MUST “submit” their choices on/before the last day of choice filling. Candidates will NOT be allowed to edit their choice list after clicking on “submit” or after the deadline for choice filling, i.e. candidates CANNOT change the order of their choices OR add/delete any more choices from their choice list after the deadline/submission of choice filling.

➔ **SEAT ALLOTMENT PROCESS**

- Candidate will be allotted one of his/her desired preferences of NIPER as per merit and category, depending on the availability.
- Candidate will be allowed to download his/her provisional allotment letter mentioning the Course/Institute allotted to him/her only after depositing the requisite fee through payment gateway.
- All the candidates who have been allotted a seat will be required to pay the requisite fee within the prescribed date and time failing which their allotment will be cancelled.
- Upon reporting at the allotted NIPER, the candidate has to produce all the relevant original documents to the officials for verification. NIPER may refuse admission if the listed documents are not found in order. The NIPER JEE 2022 organizing institute will not be a part of any such decision, taken by respective NIPER.

In case of any discrepancy, the decision of NIPER JEE 2022 committee shall be final and binding on the candidates
