# NAME OF WORK: HIRING OF 50-SEATER BUSES (QUANTITY-02) FOR ONE YEAR. PART B – COMMERCIAL BID-TERMS & CONDITIONS OF CONTRACT

Tenders are invited for the above work, details of which are as mentioned in the Price Bid.

1. The bidding is in two stages i.e. (i) Technical Bid (ii) Price Bid.

2. The Price Bids of only those bidders will be opened who qualify the first stage.

3. Bidders are requested to comply with requirements like PF Registration, ESI Registration, Labour License, Trade License etc.; if the appropriate authorities raise any such requirement/claim/challan, the contractor will have to fulfill all requirements for the which, no financial burden shall be passed on to NIPER-HYDERABAD. The full burden will have tobe borne by the contractor.

4. The successful bidder will have to furnish copies of RTO Registration, RC Book showing the model, ownership, seating capacity, tax paid, road worthiness, Fitness Certificate, PUC Certificate, insurance etc. on any day before placement of the bus. In case these documents are readily available, they can be furnished along with this technical cum commercial bid. In case successful bidder is unable to provide the required bus within the stipulated time, the offer can be treated as withdrawn and EMD may be forfeited along with other actions for suspension of business dealings in line with the guidelines of NIPER-HYDERABAD.

5. Item Sl. No. 2 of price bid shall become applicable on a monthly billing cycle only if the logged KMs during the billing cycle of one month exceed **900 KMs per bus**. This implies that the item Sl. No.2 will not be reckoned on a day to day basis.

6. The bidders are required to quote their **rates in the price bid format enclosed herewith. (There should be no cutting or over-writing in the price bid)**. The rate should include cost of Fuel, Driver, Registration, Insurance, Depreciation, Repair and Maintenance, Taxes, Duties, Profit & All Other Incidental Charges.

7. Payment will be made on the basis of actual days of deployment & Kilometers completed to different places. The initial meter reading shall be taken on reporting for duty at NIPER-HYDERABAD (HOSTEL/OFFICE). The Final meter reading shall be the meter reading at the point of completion of duty or at NIPER-HYDERABAD (HOSTEL / OFFICE).

8. The timing of the deployment of the bus can be changed by NIPER-HYDERABAD management depending upon the exigencies of work and seasonal variations. However, thetotal working hours shall not exceed 12 hours per day. No additional payment would be permissible for change in timings. On rare occasions, the working hours may be increased beyond 12 hours. However, payment will be regulated according to kilometers logged. Compensatory equal time off can be availed by the driver/conductor on mutually convenient date and time. No additional payment shall be permissible for such extra duty hours.

9. In case the contractor is unable to provide the vehicle for 12 hours on any particular day, NIPER-HYDERABAD shall have the right to make appropriate deductions which are either listed in the price bid format or which may be deemed fit for such a lapse. NIPER- HYDERABAD also reserves the right to deduct a suitable penalty amount for repeated lapsesor deliberate mismanagement.

10. The bus should report for duty for all working days. In case contract is short closed as per T&C No.11, the payment will be made till last day of the month in which the contract is closed. This condition is however subject to satisfactory fulfillment of all other terms & conditions.

11. The **validity of the contract** shall be **One Year**. The contract can be terminated by any of the parties at any point of time by giving One Month notice, in which case no compensationshall be admissible for the uncompleted period of the contract.

12. The Lowest Bid (L-1) will decided based on the rates quoted by vendors in Sl. No. 1 of Price bid (Part B of tender document) on monthly basis.

13. The successful bidder will have to deploy the vehicle within one week time of receiving Work order.

## 14. **Performance Security Deposit (PSD)**:

Security Deposit will be collected from the successful tenderer. The rate of Security Deposit will be 3% of the value of the Contract. However, the rate of percentage of P.S. is subjected changes from time to time in accordance with OM NO. F-9/4/2020-PPD dated 12.11.2020 and its subsequent amendment(if any) as issued by D.O.E, under MoF, GOI.

Security Deposit may be furnished in any one of the following forms:

(i) Pay Order, Demand Draft in favour of NIPER Hyderabad.

(ii) Bank Guarantee from Scheduled Banks/Public Financial Institutions as defined in the Companies Act. The Bank Guarantee format should have the approval of NIPER Hyderabad.

(iii) Fixed Deposit Receipt issued by Scheduled Banks/Public Financial Institutions as defined in the Companies Act. The FDR should be in the name of the contractor, A/c NIPERH Resource payable at Hyderabad, duly discharged on the bank.

(iv) Security Deposit can also be recovered at the rate of 10% from the running bills. However, in such cases at least 50% of the Security Deposit should be collected before Start of the work and the balance 50% may be recovered from the running bills.

(v) EMD of the successful tenderer can be converted and adjusted against the security deposit.

(vi) The security deposit shall not carry any interest.

(Note: Acceptance of Security Deposit against Sl. No. (iv) and (vi) above will be Subject to hypothecation or endorsement on the documents in favour of NIPER Hyderabad.

However, NIPER Hyderabad will not be liable or responsible in any manner for the collection of Interest or renewal of the documents or in any other matter connected therewith. Successful bidder will pay the stamp duty on security deposit as per government rules.

15. The monthly bills will have to be submitted in the format of the price bid adding thereto a column for amount. The deductions table will have to be filled up by the contractor with each bill. The pool supervisor will make appropriate necessary corrections before forwarding the bills for payment. Bills not submitted in the standard format, will not be accepted for which the contractor will be held responsible.

16. The contractor will have to raise monthly bills for the service rendered; these bills shall be scrutinized by NIPER Hyderabad before payment. Failure to submit the bills within 3 months of the service rendered can disqualify the contactor from any claims. NIPER Hyderabad shall not be responsible for making any payment for which bill has not been raised/submitted to NIPER Hyderabad.

17. The vehicle will be parked at our NIPER Hostel/ Office for which suitable place will be provided.

18. The driver should be well dressed in the uniform of the contractor. He should possess valid & suitable driving license at all times and should be a person of good moral character.

## **DEDUCTIONS:**

19. The vehicle will usually be deployed 12 hours a day. Appropriate relieving drivers/overtime will have to be provided by the contractor to give leave to the drivers. In case of preventive maintenance/breakdown of the vehicle, alternative vehicle will be allowed. In case vehicle is not deployed by the contractor on any particular day, a penalty equal to minimumdaily payable amount (not less than 50 KMs/day) shall be deducted from the monthly bill. In case this is repeated, NIPER Hyderabad may resort to more stringent penalties including termination of contract.

21. The driver of the vehicles should be well behaved and courteous with NIPER Hyderabad students/faculty/staff. In case of misbehavior by the driver, a penalty of up-to Rs.500.00 can be imposed for each there are multiple repetitions with a particular driver, he may have to be changed.

22. The contact person mentioned in Part-A of this bid will have to meet the concerned Officer at least once every fortnight for obtaining feedback about the operation of the bus. The instructions issued by the Officer will be noted down by the contact person in two copies, one each for the contractor and NIPER Hyderabad. Non-reporting in any fortnight can result in a penalty of Rs.100/-for each lapse. Similarly the contact person will meet the transport executiveonce every alternate month and discuss the issues for smooth running of the contract. Failure to comply with this provision can result in a penalty Rs.500/- for each lapse. A plate/paint indicating "ON NIPER-HYDERABAD DUTY" will have to be provided both on front & back of the bus.

23. Failure to report at the specified time can result in a penalty of Rs.50/- for each lapse subject to maximum 1 hour late, beyond which the penalty shall be Rs.500/-. In case of habituallate coming greater penalty can be awarded. A weekly off can be given on a day convenient to NIPER Hyderabad Management.

24. No unauthorized person should be allowed to travel in the vehicle when on NIPER-Hyderabad official duty. Failure to comply with this provision can result in penalty equivalent to 50% of trip value.

25. One set of cleaned & ironed white seat covers will have to be provided. In case of failure to do so, NIPER Hyderabad will get the same prepared and deduct the amount from the bills apart from recovering a penalty of Rs.500/-.

26. The driver will have to be provided with a mobile phone. He will keep the mobile phone charged and in fully operative condition. Failure to keep/keep ON the phone would entail a penalty of Rs.50/- per day subject to maximum Rs.500/- per month.

27. In case of breakdown of the vehicle on any day, another similar vehicle will have to be provided. In case of failure to provide another similar vehicle, a penalty of Rs.500/- per day will be imposed. This will be allowed only for maximum 7 days, after which management reserves the right to terminate the contract at the risk & cost of the bidder.

28. The vehicle will have to be maintained by the contractor in good running condition which includes at least the following:

- (i) Minimum noise of engine and body while running
- (ii) Tyres with proper treads.

(iii) Inflated stepni Working headlights, tail lamps, indicators, speedometer, milometer, temperature indicator etc.

- (iv) Proper paint on the outside.
- (v) Good condition of bumpers
- (vi) Upholstery in good condition including washed and ironed white seat covers.
- (vii) Proper locking of all doors
- (viii) Proper closing and opening of all windows.

(ix) Dusting of dashboard, rear board, matting, windscreen, windows and body. Failure to maintain the same would invite penalty @ 2% of bill for each failure for the duration of the failure/lapse.

29. The contractor has to ensure that filling of the fuel in the vehicle is done from the Petrol Pump situated nearby NIPER Hyderabad. In case it is found otherwise, penalty of Rs.250/-per occasion can be deducted from the contractor's bills.

30. The bidder will have to maintain a logbook provided by us and the signature(s) of the authorized person to travel will have to be obtained to certify the trips; failure to obtain the name & signature can deprive him of payment for the trip. The logbook will be the Company's property and your driver has to keep it in the safe custody. No unauthorized person should be allowed to travel in the vehicle when on NIPER-Hyderabad official duty. Failure to comply with this provision can result in non-payment of the trip.

# SPECIAL:

31. Contractor/Operator will have to fulfill all legal obligations regarding minimum wages, PF, ESI, Pollution norms, Motor Vehicle Act, Service tax etc. as may be applicable to him. The vehicle should have valid taxi permit issued by R.T.O. Hyderabad. The vehicle must be comprehensively insured for driver, passengers & the third party for the period of the contract.

32. The contractor has to abide by all laws, rules & regulations applicable to this type of work. Ignorance of the same does not entitle him to any concessions or claims.

33. All disputes arising in connection with the contract shall be settled by mutual consultation. If no agreement is reached, the dispute shall be settled in accordance with Arbitration and Conciliation Act, 1996 and the rules made thereunder. The dispute shall be referred for arbitration to any arbitrator to be appointed by the Head of the Organisation. The award of the arbitratorshall be final and binding on both the parties. The venue of the

Arbitration shall be at Hyderabad (Telangana) in India. The Award to be given by the Arbitration shall be a speaking award. All questions, disputes, differences arising under, out of or in connection with this contract shall be to the exclusive jurisdiction of Hyderabad court.

34. Any matter of dispute arising out of or in connection with this contract shall be under jurisdiction of Hyderabad Court only.

35. The Contractor has to make an agreement with NIPER Hyderabad in the format prescribed only on Rs.100/- Non-Judicial Stamp Paper.

36. In case of non satisfactory performance of the contract, NIPER Hyderabad shall have aright of forfeiting the security deposit.

37. The contractor shall compensate NIPER Hyderabad for any loss or damage to the plant/property, material of NIPER Hyderabad due to his workmen/representatives' negligence or otherwise during execution of work contract.

<sup>38.</sup> The contractor shall get the character & antecedents of his own labours verified from District Magistrate's office and intimate the same to the management before deploying themto work.

39. NIPER Hyderabad reserves the right to accept or reject any or all offers without assigning any reason(s). The dispute arising out of or in relation of this agreement shall be referred to arbitrator, appointed by NIPER Hyderabad, who may be a serving/retired Sr. Officer or any other person of repute whose award shall be binding on both the parties to the agreement. In case any of the parties decides to obtain relief from the court, the dispute arising out this agreement shall be subject to Hyderabad jurisdiction.
