1. Quotations received after due date & time shall be summarily ignored.
2. Each quotation sent by post is to be enclosed in double cover. The cover should be SEALED WITH AND SUPERSCRIBED with tender number and due date. Quotations should be addressed to **“Director NIPER HYD”** and delivered personally should be put in the tender box kept in the office of Stores & Purchase, NIPER Hyderabad. All the bids are to be submitted in two bid system i.e. technical and commercial bids separately in different sealed covers. **The EMD amount of Rs.85,880/-** in the form of DD or bankers Cheque in favour of **“NIPER-H Resources”** should be kept in the technical bid cover to avoid its disqualification.
3. The quotation sent by Fax/e-mail, can be accepted at your risk provided the quotation reaches the Purchase Dept. within the due date & time . **If the Tender Opening Day falls on a Public Holiday , the tender will be opened on next working day. Quotations should be submitted only on working days.**
4. **The bids would be opened in the presence of the bidders who wish to attend the Bid-opening. However the representative should bring with them a letter of authority from the corresponding bidders, without which, they are not permitted to attend the Bid-opening.**
5. The acceptance of the quotation will rest with the competent authority of NIPER, Hyderabad who does not bind himself to accept the lowest quotation and reserves the

right to himself to reject, or partially accept any or all the quotations received without assigning any reasons.

6. **Your offer shall be valid for ninety days from the date of opening of the quotations. No revision in price will be allowed after opening the quotation.**
7. **Unsolicited/conditional/Unsigned tenders shall not be considered.**
8. **Wherever the quoted price is more than Rs.10.00Lakhs unconditional Performance guarantee for 10% of the purchase order value valid till 60 days beyond end of warranty period need to be given.**
9. **Send your offer indicating the basic cost, taxes, packing, forwarding, freight, transportation, insurance, installation & commissioning charges etc., separately to ascertain the F.O.R NIPER HYD destination prices. The offers which are not complying with this condition are liable for rejection. Where there is no mention of these charges, the offer would be rejected as incomplete unless the prices quoted are on F.O.R destination prices.**

Specification for Freeze Dryer

- The instrument should have ice condenser made with stainless steel coil inside the chamber to trap moisture.
- It should be compact bench top system.
- Performance should be 2.2 litre of water in 24 hr and ice holding capacity at least 2 kg or more.
- The ice condenser temperature -84° or better with drain valve for disposal of defrosts material.
- Stainless steel chamber with more than 4 port connections with individually controlled rubber valve suitable for flask, with connectors. Vendor should quote largemouth flask, rubber top for easy clean and retrieval of sample in powder form along with stainless steel connectors.
- Electromagnetic pressure control for vacuum control.
- Should have vacuum break valve to prevent oil back streaming.
- It should have graphical and LCD display or only LCD for ice condenser, temperature and vacuum level and alarm message.
- Refrigeration system should be HCFC/CFC free.
- It should have automatic and manual startup.
- Noise: To the safety level preferably below 55dB
- Moisture sensor to protect the vacuum pump will be preferable.
- Facility for Sample temperature dryness check during drying stage
- System should have provision to start pump after condenser temp reaches -400°C for safety
- 1 or more number of compressors for better performance
- Instrument should be quoted for at least 1 year of comprehensive warranty and local support along with service engineer stationed nearby.
- Flasks required: Wide mouth flasks of 150 ml and 300 ml – 2 each and Round Bottom Flasks of 250 ml and 500 ml – 2 each with suitable stainless steel adapters, O-rings, filter papers, flask cover (rubber lid) should be supplied for all the Flasks - Mechanical Crimper for sealing of Aluminium Caps.30

- Thermal shake touch having color display with interior memory to store 5 program having temperature range of 4° above ambient to 100° C. and shaking speed 300 – 3000 RPM on 3 mm orbit, along with 1.5 ml block.
- Manufacturer should be ISO 9001, CE conformity marking.
- Vendor will provide user list. The machine should be duly certified / authorized and the vendor should produce the certificate for the same.
